*Africa's most urgent priorities, including financial sustainability, debt action, and climate finance, are the focus of this first plenary, which highlights interfaith recommendations on the G20's responsibilities for the global financial architecture. Priorities for food security, migration and refugees, disaster preparedness, and education and health are intricately linked to this framework, including action by multilateral banks and private actors. The G20 Interfaith Forum's primary goal*

*and priority is action to support the world's most vulnerable communities, an imperative shared by diverse religious communities around the world in their teachings and practice. South Africa's G20 agenda, the global agendas for the Sustainable Development Goals (SDGs), and Africa 2063 (African Union) echo this critical attention to action to address issues of poverty and hunger, inequalities that hinder the flourishing of women and families, and national development strategies.*
